Where do your dues go?

Based on funding availability, a portion of the membership dues will be allocated to the Bracken Tuition Assistance Fund and the BCS Alumni Scholarship Fund.

Bracken Tuition Assistance Fund: Applicants will be vetted by the Bracken administration for tuition assistance based on financial need. Funds will be distributed through the Bracken Tuition Assistance Fund

BCS Alumni Scholarship Fund: Scholarships for college or trade schools post-graduation. Bracken Seniors will complete the application process and be selected for a scholarship that will be paid directly to the trade school, trade program, college, or university they will be attending to assist with tuition costs or enrollment fees.
